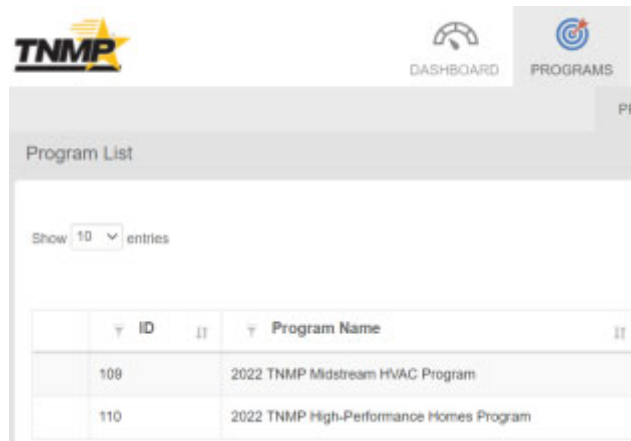

## 2022 Program Milestones

*Table 4 – Milestone Dates*

Date	Performance Milestone Date Requirements
<b>April 30, 2022</b>	At least 20% of total committed homes/systems must be <b>entered</b> on the Program's online system; Homebuilder must have selected at least one preferred HERS Rater or Contractor to the online system.
<b>June 30, 2022</b>	At least 60% of total committed homes/systems must be <b>entered</b> on the Program's online system <b>and</b> the required documentation for the invoiced homes must be uploaded to the online system.
<b>September 30, 2022</b>	At least 85% of total committed homes/systems must be <b>invoiced</b> on the Program's online system <b>and</b> the required documentation for the invoiced homes must be uploaded to the online system.
<b>November 30, 2022</b>	100% of total committed homes/systems must be <b>invoiced</b> on the Program's online system <b>and</b> the required documentation for the invoiced homes must be uploaded to the online system.

It's time to upload starts to the TNMP Database!



Work with your HERS Rater to ensure your homes starts are being submitted within 45 days of their permit date so we can see your progress in delivering on your allocation of incentive funds. We will be working closely with all of you as each program milestone approaches to make sure you are on track.

The EELC is an online distance-learning portal where contractors can log in to take trainings on **Sales and Marketing, Technical Topics, and Best Practices**. Contractors are also able to view recorded webinars, demonstrations, and other program related training materials.

Many courses can also be used to meet Continuing Education Unit (CEU) requirements for common industry certifications, including NATE, RESNET, and BPI. All courses eligible for CEUs have a short exam and require an 80% or higher score to pass.
