Use Bonds to Boost Sales

Recently, three Texas metropolises appeared in Forbes' latest list of America's fastest-growing cities. This economic growth that we're experiencing requires the construction of new schools and municipal services. To meet this need, many districts and cities are using bonds to fund new construction projects and to upgrade existing buildings.

Four Seasons is Shining Brighter

Four Seasons, a division of Standard Motor Products, Inc., recently replaced 490 metal halide lighting fixtures with 424 four-lamp T5HO fixtures. The new lights will slash annual electricity consumption at Four Seasons' Lewisville warehouse by 1,393,118 kilowatt-hours – an amount that's equivalent to the annual greenhouse gas emissions from over 200 passenger vehicles, according to the Environmental Protection Agency. The project also earned Four Seasons a \$58,051 incentive from TNMP's Commercial Solutions Program. Thanks to Texal Energy for helping to make this happen!






Dickinson ISD Saves Big

Dickinson Independent School District recently underwent energy performance benchmarking courtesy of TNMP's SCORE Program. This is the second time that the district has been benchmarked by the program, at no cost.

As a result of the benchmarking, Dickinson ISD's dedicated energy management team was able to quantify the improvement in facility energy usage from 2008 (the year the district was first benchmarked) to 2013. During this period, the district's average energy use index (kBtu per square foot) dropped from 50.9 kBtu/SF to 37.4 kBtu/SF. That's an improvement of over 25 percent! The below graph shows how Dickinson's recent benchmarking score compares to other school districts in the Houston/Gulf Coast region. Congratulations, Jeff Pulkinen and Dickinson ISD!
