#### **Updated Incentive Rates for 2015!**

Happy New Year and welcome back for another great year of energy efficiency incentives and services from TNMP. We are excited to announce updated incentive rates for commercial customers and facilities in the TNMP service area. As always, you can visit **www.tnmpefficiency.com** for the latest program documents, savings calculators and incentive rates.

For Commercial Solutions (most medium and large sized commercial facilities), all incentives remained the same except for two categories: LED Lighting and Other/Custom. Both increased to \$150/kW + \$0.03/kWh.

**SCORE**<sup>®</sup>/**CitySmart**<sup>®</sup>: Incentive rates now include an energy saving component, i.e. \$0.02/kWh saved, for all program tracks. This change allows the program to work with customers in these markets on a wider range of measures, including those focused on "off-peak" energy savings.

- SCORE/CitySmart, comprised of all K-12, higher education, and local government facilities: \$150/kW + \$0.02/kWh
- SCORE/CitySmart Lite, comprised of select SCORE/CitySmart participants who elect to receive higher cash incentives in exchange for lower levels of program support/services: \$175/kW + \$0.02/kWh
- Small SCORE, comprised of select K-12 with less than 2,000 students: \$250/kW + \$0.02/kWh

Texas-New Mexico Power offers a portfolio of commercial energy efficiency programs.

The SCORE® Program provides viable energy optimization for school districts, colleges and universities. Designed to educate institutions on energy management and encourage investment in energy efficiency, this program helps partners minimize the impact of volatile energy costs, ease budget pressures, improve infrastructure and optimize learning environments for students.

The CitySmart® Program helps local government entities enhance energy efficiency, lower operating costs, improve air and environmental quality, and meet legislative and regulatory requirements.

Similar to SCORE and CitySmart, the TNMP Commercial Solutions Program provides technical and financial support to help commercial and industrial organizations identify and implement energy efficiency upgrade projects.

The Open Program for small businesses program targets commercial facilities below 100kW in demand usage to enable them to participate in energy saving retrofits.

### **Project Spotlight-Lewisville Christian School**

Lewisville Christian realized the benefits from TNMP's energy efficiency services, saving \$25,000 annually by replacing their 900 T12 fixtures with LED lighting, as well as replacing their 100-watt incandescent bulbs with 13-watt bulbs. The school's incentive check was an added bonus, totaling \$11,086.
