

## Are you a homebuilder in West Texas?




## 2025 Program Documents and Milestones

Date	Performance Milestone Date Requirements
<b>April 30, 2025</b>	At least 20% of total committed homes/systems must be <u>entered</u> on the Program's online system; Homebuilder must have selected at least one preferred HERS Rater or Contractor to the online system.
<b>June 30, 2025</b>	At least 60% of total committed homes/systems must be <u>entered</u> on the Program's online system <u>and</u> the required documentation for the invoiced homes must be uploaded to the online system.
<b>September 30, 2025</b>	At least 85% of total committed homes/systems must be <u>invoiced</u> on the Program's online system <u>and</u> the required documentation for the invoiced homes must be uploaded to the online system.
<b>November 30, 2025</b>	100% of <u>total</u> committed homes/systems must be <u>invoiced</u> on the Program's online system <u>and</u> the required documentation for the invoiced homes must be uploaded to the online system.


Our latest outreach campaign is focused on raising awareness about energy-efficient homebuilding and encouraging West Texas residents to choose high-performance homes.
